This RFI is issued solely for information and planning purposes – it does not constitute a request for proposals or a promise to issue a solicitation in the future. This request for information does not commit UCC to contract for any supply or service whatsoever. Further, UCC is not, at this time, seeking proposals and will not accept unsolicited proposals. Respondees are advised that UCC will not pay for any information or administrative costs incurred in response to this RFI; all costs associated with responding to this RFI will be solely at the interested party's expense.
